ORDER APPROVING WITHDRAWAL OF FORM A STATEMENT

On June 25, 2013, SCOR Global Life Americas Holding Inc., SCOR Global Life S.E., and SCOR S.E. (“Applicants”) filed a Form A Statement proposing to acquire control of Generali USA Life Reassurance Company. The Director issued a Notice of Hearing setting the matter for public hearing on August 14, 2013.

On August 6, 2013, Applicants submitted a letter requesting continuance of the August 14, 2013 hearing. On August 7, 2013, the hearing officer granted Applicants’ request for continuance, but the matter was not reset for hearing.

On September 3, 2013, Applicants requested the withdrawal of the Form A Statement. Applicants indicated that on August 27, 2013, the Director issued a Final Order for Approval of Redomestication, which approved the redomestication of Generali USA Life Reassurance Company to the State of Delaware.

Applicants’ request to withdraw its Form A Statement is reasonable and for good cause.

IT IS THEREFORE ORDERED that the request of SCOR Global Life Americas Holding Inc., SCOR Global Life S.E., and SCOR S.E. to withdraw the Form A Statement is approved and the matter is dismissed without prejudice.
