VOLUNTARY FORFEITURE

It is hereby agreed by Raymond Plante and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 374, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating bail bond agents and general bail bond agents in the bail bond business pursuant to Section 374.085, RSMo (2000) and Section 374.764, RSMo (Cum. Supp. 2008) and is authorized by the director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Raymond Plante is licensed as a bail bond agent and the registered 'President of ASAP Bail Bonds, Inc;

WHEREAS, information has been received by the Consumer Affairs Division concerning Raymond Plante's violation of 1) Section 374.755.1 (3) RSMo (Cum. Supp. 2008) – Use of fraud, deception, misrepresentation or bribery in securing any license by failing to disclose three outstanding forfeitures in the Municipal Court of Ferrelview; and 2) Section 374.755.1(5) RSMo (Cum. Supp. 2008) – Misrepresentation in the performance of the duties of the profession by reflecting the name of a non-qualified individual on a power of attorney, which subjects Raymond Plante to enforcement action by the Director;

WHEREAS, Raymond Plante has been informed of the nature of his violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his general bail bond license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the bail general bond license of Raymond Plante or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Raymond Plante, does hereby voluntarily and knowingly surrender and forfeit the sum of \$400.00 such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Raymond Plante shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than April 30, 2009.
