VOLUNTARY FORFEITURE AGREEMENT

It is hereby agreed to by Apollo Insurance Group, Inc. ("Apollo") and the Division of Consumer Affairs ("Division") of the Department of Commerce and Insurance, as follows:

WHEREAS, Chlora Lindley-Myers, is the duly appointed Director of the Department of Commerce and Insurance, State of Missouri (hereinafter, "Director" of the "Department"), whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Division is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Apollo Insurance Group, Inc. ("Apollo"), holds an active business entity producer license with the Department, pursuant to Chapter 375, RSMo;

WHEREAS, the Division has received information that Apollo allowed an employee to sign the name of another to an application for insurance without authorization, which is a violation of Section 375.144, RSMo and Section 374.141.3, RSMo. Additionally, Apollo materially aided an employee to conduct the business of insurance without a valid insurance producer license, which violates Section 375.145.1, RSMo. These violations subject Apollo to enforcement action by the Director;

WHEREAS, Apollo has been informed of their right to counsel and of their right to contest any attempt by the Department to discipline their business entity producer license, and states that they understands their rights to contest any such actions;

AND WHEREAS, Apollo acknowledges and admits for purposes of this Agreement and for purposes of any future action by the Director or the Division based on an additional violation of the insurance laws or regulations by Apollo, in which action the Director or the Division alleges that the violation described herein forms part of a course of conduct, a business practice, or other such series of similar violations, or that future violations by Apollo are committed knowingly, intentionally or in conscious disregard of the law. Apollo allowed an employee to sign the name of another to an application for insurance without authorization, which is a violation of Section 375.144, RSMo and Section 375.141.3, RSMo. Additionally, Apollo materially aided an employee to conduct the business of insurance without a valid insurance producer license, which violates Section 375.145.1, RSMo.

NOW, THEREFORE, in lieu of any recommendation or initiation by the Division of any action based on the violation cited in this Agreement, and after being afforded the opportunity to

consult legal counsel, Apollo does hereby voluntarily and knowingly surrender and forfeit the sum of One thousand five hundred dollars (\$1,500.00), such sum to be paid into the State School Moneys Fund pursuant to Sections 374.046 and 374.280, RSMo.

Apollo shall submit this sum to the Department by cashier's check or money order made payable to the State School Moneys Fund no later than July 26, 2023.

The parties agree that, should the Director or the Division in the future allege an additional violation of the insurance laws or regulations by Apollo, nothing in this Agreement shall preclude the Director or the Division from introducing Apollo's admissions contained in this Agreement as evidence that the acts described herein form part of a course of conduct, a business practice, or other such series of similar violations, or for purposes of showing that such later alleged acts are committed knowingly, intentionally or in conscious disregard of the law.
