**VOLUNTARY FORFEITURE**

It is hereby agreed by Katelynn Leigh Gillis and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, John M. Huff is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri, (hereinafter, Director) whose duties, pursuant to Chapters 374, 375 and 381, RSMo include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Sections 374.085 and 374.190, RSMo 2000 and is authorized by the Director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Katelynn Leigh Gillis has applied for her license renewal as a producer with the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapters 374, 375 and 381, RSMo;

WHEREAS, the investigation by the Consumer Affairs Division revealed that Katelynn Leigh Gillis violated the insurance laws and is subject to enforcement action by the Director for the following:


Katelynn Leigh Gillis conducted business without a Producer License from December 28, 2011 to August 28, 2012, therefore violating Section 381.115.2(2) and 375.014, RSMo.

WHEREAS, Katelynn Leigh Gillis has been informed of the nature of the violation, of her right to counsel and of her right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to refuse her license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that she understands her rights to contest any such actions;

NOW, THEREFORE, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to refuse the license of Katelynn Leigh Gillis or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Katelynn Leigh Gillis does hereby voluntarily and knowingly surrender and forfeit the sum of \$1,300.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

Katelynn Leigh Gillis shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than December 12, 2012.


