VOLUNTARY FORFEITURE

It is hereby agreed by Raymond Plante and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, Linda Bohrer is the duly appointed Acting Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 374, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating bail bond agents and general bail bond agents in the bail bond business pursuant to Section 374.085, RSMo (2000) and Section 374.764, RSMo (Cum. Supp. 2007) and is authorized by the director to recommend enforcement action under the laws relating to insurance;

WHEREAS, Raymond Plante is licensed as a general bail bond agent;

WHEREAS, information has been received by the Consumer Affairs Division


concerning Raymond Plante's violation of Section 374.702.2 (6) RSMo (Cum. Supp. 2007) Having been found to have permitted an unlicensed person to solicit or engage in the bail bond business on the general bail bonds agent's behalf, except for individuals who are employed solely for the performance of clerical, stenographic, investigative, or other administrative duties which do not require a license; and 2) Section 374.755.1 (10) RSMo (Cum. Supp. 2007) by assisting or enabling any person to practice the profession licensed or regulated by sections 374.695 to 374.789 who is not currently licensed and eligible to practice pursuant to sections 374.695 to 374.789, which subjects Raymond Plante to enforcement action by the Director;

WHEREAS, Raymond Plante has been informed of the nature of his violation, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his general bail bond license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in complete settlement of the investigation in File Number 08A000629, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the bail general bond license of Raymond Plante or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Raymond Plante, without any admission of a violation of the law, does hereby voluntarily and knowingly surrender and forfeit the sum of \$2,387.45 such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.




