## **VOLUNTARY FORFEITURE**

It is hereby agreed by CHRISTOPHER M. PARR and the Consumer Affairs

Division of the Department of Insurance, Financial Institutions and Professional

Registration, as follows:

WHEREAS, Douglas M. Ommen is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapter 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085, RSMo 2000 and is authorized by the Director to recommend enforcement action under the laws relating to insurance.

WHEREAS, CHRISTOPHER M. PARR is licensed as an insurance producer by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 375, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division concerning CHRISTOPHER M. PARR, which alleges the following violations, grounds for enforcement action by the Director against the insurance producer license of CHRISTOPHER M. PARR:

- Violation of Section 375.936(4) RSMo 2000, circulated and placed before
  the public in a newspaper advertisement selling certificates of deposit
  under his securities license, but ended up selling under insurance
  producer's license an annuity, not advertised in the same advertisement,
  grounds for discipline under Section 375.141.1(2) RSMo Cum Supp 2006,
- Violation of Section 375.015.2 RSMo Cum Supp 2006 and 20 CSR 700-1.110, by not licensing First Capital Group, Inc. as a business entity insurance producer in the State of Missouri, grounds for discipline under Section 375.141.1(2) RSMo Cum Supp 2006, subjecting him to enforcement action by the Director;

WHEREAS, CHRISTOPHER M. PARR has been informed of the nature of his violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his insurance producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in complete settlement of the investigation in File Number 07A000020, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the insurance producer license of CHRISTOPHER M. PARR or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, CHRISTOPHER M. PARR, without any admission of a violation of the law, does hereby voluntarily and knowingly surrender and forfeit the sum of \$500.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

CHRISTOPHER M. PARR shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than July 13, 2007.
