VOLUNTARY FORFEITURE

It is hereby agreed by NAVARRO D SIMMONS and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, Linda Bohrer, or her successor, is the duly appointed Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085, RSMo 2000 and is authorized by the Director to recommend enforcement action under the laws relating to insurance.

WHEREAS, NAVARRO D SIMMONS is licensed as an insurance producer by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapter 375, RSMo;

WHEREAS, the investigation by the Consumer Affairs Division revealed NAVARRO D SIMMONS violated our insurance laws and is subject to enforcement action by the Director for the following:

1. Violation of Section 375.022 RSMo (Cum. Supp. 2007), By assisting with or completing an application for Susan Lewis and not being listed as an appointed insurance producer to sell, solicit or negotiate contracts of insurance on behalf of the insurer, which is grounds for discipline under Sections 375.141.1(2) and 375.145.1 RSMo (Cum. Supp. 2007);
2. Used coercive and dishonest practices, demonstrated incompetence and untrustworthiness by completing an unsolicited bank authorization form during the sales process of the OM Financial Life insurance policy to Susan Lewis, which is grounds for discipline under Sections 375.141.1(8) and 375.145.1 RSMo (Cum. Supp. 2007).

WHEREAS, NAVARRO D SIMMONS has been informed of the nature of his violations, of his right to counsel and of his right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline his insurance producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that he understands his rights to contest any such actions;

NOW, THEREFORE, in complete settlement of the investigation in File Number 08A000487, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to revoke or suspend the

insurance producer license of NAVARRO D SIMMONS or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, NAVARRO D SIMMONS, without any admission of a violation of the law, does hereby voluntarily and knowingly surrender and forfeit the sum of \$2000.00, such sum to be paid into the Missouri State School Fund pursuant to Sections 374.046 and 374.280, RSMo.

NAVARRO D SIMMONS shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than October 3, 2008.


