## VOLUNTARY FORFEITURE

It is hereby agreed by Superior Performers a/b/a National Agents Alliance and the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration, as follows:

WHEREAS, Linda Bohrer is the duly appointed Acting Director of the Department of Insurance, Financial Institutions and Professional Registration, State of Missouri (hereinafter, Director) whose duties, pursuant to Chapters 374 and 375, RSMo, include the supervision and regulation of the business of insurance;

WHEREAS, the Consumer Affairs Division of the Department of Insurance, Financial Institutions and Professional Registration is charged with investigating producers and companies engaged in the business of insurance pursuant to Section 374.085, RSMo 2000 and is authorized by the Director to recommend enforcement action

under the laws relating to insurance.

WHEREAS, the business entity insurance producer license of Superior Performers d/b/a National Agents Alliance is currently expired, but application is pending by the Department of Insurance, Financial Institutions and Professional Registration, pursuant to Chapters 374 and 375, RSMo;

WHEREAS, information has been received by the Consumer Affairs Division concerning the Mortgage Protection Center name and usage of that name by Superior Performers d/b/a National Agents Alliance in the state of Missouri without it being properly licensed as a business entity producer;

WHEREAS, information has been received by the Consumer Affairs Division concerning Superior Performers d/b/a National Agents Alliance advertising and soliciting life and disability insurance by mailing to Palmyra State Bank customers circulars without properly identifying the insurance company responsible for the financial obligation under the policy;

WHEREAS, Superior Performers d/b/a National Agents Alliance has been informed of the nature of their violations, of their right to counsel and of their right to contest any attempt by the Department of Insurance, Financial Institutions and Professional Registration, to discipline their business entity producer license, or to recover whatever penalties or other monetary relief as may be provided for by statute, and states that they understand their rights to contest any such actions;

NOW, THEREFORE, in complete settlement of the investigation in File Number 08A000280, in lieu of the institution by the Department of Insurance, Financial Institutions and Professional Registration of any action to refuse to renew the business

entity insurance producer license of Superior Performers or to impose any other penalties provided for by statute for the above-described violations, after being afforded the opportunity to consult legal counsel, Superior Performers d/b/a National Agents Alliance, without any admission of a violation of the law, does hereby voluntarily and knowingly surrender and forfeit the sum of two thousand dollars (\$2,000), such sum to be paid into the Missouri State School Fund pursuant to Sections 374,046 and 374,280, RSMo (Cum. Supp. 2007).

Superior Performers d/b/a National Agents Alliance shall submit this sum to the Department of Insurance, Financial Institutions and Professional Registration, by cashier's check or money order made payable to the Missouri State School Fund no later than August 15, 2008.
